Subject: Release of recurring Grants-in-Aid to the Union Territory of Chandigarh for the implementation of Centrally Sponsored State Managed (CSSM) component of Pradhan Mantri Kaushal Vikas Yojana 3.0 (PMKVY 3.0) by Chandigarh Skill Development Mission (CSDM) for the year 2022-23– reg.

I am directed to convey the sanction of the President of India for the payment of recurring grant-in-aid amounting to Rs. 16,88,000/- (Rupees Sixteen Lakh Eighty-Eight Thousand only) to the UT of Chandigarh towards the implementation of the CSSM component of PMKVY 3.0 by CSDM for the year 2022-23

2. The expenditure may be debitable to (Demand Number 92- MSDE):

3. The funds which are being released through this sanction order have two parts i.e. training cost and other costs (i.e. Admin and Technical Interventions, Awareness & Mobilization and Post Placement costs). As the CSSM component of PMKVY 3.0 is being implemented by SSDMs (State Skill Development Missions) along with DSCs (District Skill Committees), the funds under other costs have been provisioned separately for SSDMs and DSCs in the guidelines and the same is given below:

4. Finance Department, Chandigarh Administration is requested that funds sanctioned / authorized through this sanction order shall be transferred to CSDM immediately. Also, CSDM is requested that funds earmarked for DSCs shall be transferred immediately on the receipt of the funds under intimation to this Ministry.

5. The release is subjected to the following terms and conditions:

- i. Fund disbursement/transfer under the scheme shall be made through the Public Financial Management System (PFMS).
- ii. Fund disbursement by the implementation agency will follow the PMKVY scheme guidelines and all the provisions of the scheme have to be complied with.

- iii. Fund shall be utilized only for the purpose for which it is being released. Utilization Certificate along with audited statements of accounts should be furnished to the Ministry of Skill Development & Entrepreneurship, Govt as per General Financial Rules (GFR) 2017.
- iv. The expenditure shall not exceed the budget allocated.
- v. In accordance with Rule 230 (8) of GFR 2017, all interests or other earnings against Grants in aid or advances (other than reimbursement) released should be mandatorily remitted to the Consolidated Fund of India immediately after finalisation of the accounts through Non-Tax Receipt Portal (NTRP).
- vi. Any deviation/non-compliance of instructions/guidelines shall affect the further distribution of funds.

6. On receipt of sanction letter, the Pay and Accounts Officer may issue an intra governmental authorization letter under the functional head 2230-Grants-in-aid General to Chandigarh Administration for FY 2021-22. The controller details of UT of Chandigarh are given below:

Controller: 051 – AG UT Chandigarh.
PAO: 070855 – AG UT Chandigarh.
DDO: 290350 – DDO, Directorate of Technical Education.

7. The accounts of the grantee institutions will be open to audit by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry.

8. This is the first tranche (i.e. Tranche 1) of the funds earmarked for the States/UTs under CSSM component of PMKVY 3.0 (2020-22). Earlier funds (Tranche-I) was released to UT under CSSM-PMKVY 3.0. However, the funds lapsed due to non-utilization of fund with in financial year. On the basis of fresh requisition under PMKVY 3.0, funds are being released as Tranche-I through this sanction letter.

9. This issues with the concurrence of Integrated Finance Division (IFD) vide FTS NO. 40888 (Note No. 41)/JS&FA dated 09.11.2022 and approval of Secretary, MSDE vide FTS No. 40888 /Secretary (Note No. 47) dated 15.11.2022. This is noted at S. No. 4 of the register of grant for PMKVY 3.0 for FY 2021-22.
