(B) Functions

The functions of the Samiti will be to render advice with regard to the implementation of the provisions relating to Official Language contained in the constitution, Official language Act and Rules, and policy decisions of the Kendriya Hindi Samiti and instructions issued by Ministry of Home Affairs (Department of Official Language) relating to official language and also with regard to the progressive use of Hindi in the Ministry.

(C) Tenure

The term of the committee shall be three years from the date of its constitution, provided that-

1. Members of Parliament who are members of the Committee shall cease to be members of this Committee as soon as they cease to be members of the Parliament.
2. Official members of the Committee shall continue to be members so long as they hold the office by virtue of which they have been made a member of the Committee.
3. During the tenure of the Committee, if any person is nominated as a member of the Committee, he shall be a member only for the remaining period of the tenure of the Committee.

(D) Traveling and other Allowances

- (i) The Members nominated in the Samiti, will be paid Travelling Allowance/ Daily Allowance as per the provisions in the 'Members of Parliament (Salary, Allowances and Pension) Act, 1954' and the rates and rules as amended/fixed from time to time vide Department of Official Language OM No.11/20034/34/2005-O.L. (Policy-2), dated 03.02.2006 for participating in the meetings of the Samiti.
- (ii) Travelling Allowance/Daily Allowance to other non-official members of the Samiti will be paid as per guidelines contained in the Department of Official Language O.M. No.II/22034/04/86-OL (A-2) dated 22.1.1987 keeping in view of the high level status of the Committee and in accordance with the prescribed rates and rules as amended from time to time by the Government of India.

ORDER

Ordered that a copy of this resolution be communicated to all the members of the Committee, all State Governments and Union Territory Administrations, President's Secretariat, Prime Minister's Office, Cabinet Secretariat, Ministry of Parliamentary Affairs, Lok Sabha Secretariat, Rajya Sabha Secretariat, Niti Aayog and to the Comptroller and Auditor General of India, the Accountant General, Central Revenue and all Ministries and Departments of the Government of India.

Ordered also that the resolution be published in the Gazette of India for the information of the general public.
